Tuition & Fee Payment Preference Plan

Option 2, 3, or 4 requires an automatic draft from your bank account through the FACTS management program. If you have not used the FACTS program before, you must fill out the FACTS Agreement Form that can be obtained from the office if you are new to the FACTS program.

Tuition Payment Options for the 2010-2011 school year are as follows: **Please Circle all Options that apply**

Option 1 Single Payment with a 1% discount due July 15, 2010.

Option 2 FACTS Two Payment Plan due July 5 or 20, 2010 **and** December 5 or 20, 2010.

Option 3 FACTS Monthly Payment Plan with payments budgeted over 10 months beginning in July 2010 and ending in April 2011. Payments can be made either on the 5th or the 20th.

Option 4 FACTS Monthly Payment Plan with payments budgeted over 12 months beginning in July 2010 and ending in June 2011. Payments can be made either on the 5th or the 20th.

Option 5 Divide Fees that are due in August 2010 with FACTS payments (**2 payments, 10 payments, 12 payments**)
